Annex 1 – Mandatory conditions

1. Alcohol

(1) No retail sale of alcohol may be made under the premises licence:

(a) at a time when there is no designated premises supervisor in respect of the premises licence, or(b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

(2) Every retail sale of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Age Verification Policy:

(1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

(2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

(3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either -

- (a) a holographic mark, or
- (b) an ultraviolet feature.

Irresponsible Promotions:

(1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises -

(a) Games or other activities which require or encourage, or are designed to require or encourage, individuals to-

(i) Drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or

(ii) Drink as much alcohol as possible (whether within a time limit or otherwise;

(b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries significant risk of undermining a licensing objective;

(c) Provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner that which carries significant risk of undermining a licensing objective;

(d) Selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;

(e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).

Free tap water:

The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

Availability of Certain Measures of Alcohol:

The responsible person must ensure that-

(a) Where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-

(i) Beer or Cider: 1/2 pint;

(ii) Gin, Rum, Vodka or Whisky: 25 ml or 35 ml; and

(iii) Still wine in a glass: 125 ml; and

(b) These measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and

(c) Where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

Minimum Pricing

A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

Annex 2 – Conditions consistent with the Operating Schedule

The prevention of crime and disorder

- 1. A CCTV system will be in operation at the premises and recorded images shall be retained for a minimum period of 28 days (14 days for digital systems). The CCTV system shall be maintained in good working order, shall record at all times the premises are open. CCTV images will be provided to the police and other responsible authorities if requested as soon as practicable.
- 2. The correct time and date will be generated onto both the recording and the real time image screen
- 3. Any person left in charge of the premises must be trained in the use of any such CCTV equipment, and be able to produce CCTV images to an officer from a responsible authority upon request.
- 4. The designated premises supervisor will undertake a risk assessment to determine if SIA registered door supervisors should be employed during times of expected increased demand and/or capacity such as, but not limited to, bank holiday weekends, horse racing events and/or festivals. If SIA door supervisors are required and if deemed necessary the rate employed shall be 1 per 100 of occupancy (or part thereof) and subject to a minimum of 2 door supervisors.
- 5. On nights where door staff are required, once all customers have dispersed from inside the premises, at least one SIA door supervisor will be present on the street outside the premises wearing a High Visibility jacket (for a minimum of 30 minutes or until all customers have dispersed if earlier) to assist with the safe and quiet dispersal of customers in the immediate vicinity.
- 6. When door staff are used they will be Security Industry Authority (SIA) approved and operate in accordance with the security industry guidelines.
- 7. A zero tolerance policy towards illegal drugs will be enforced at all times.
- 8. If a DJ is used on any night then he/she will ask customers to leave quietly.
- 9. All instances of crime and disorder will be reported to the Police and will be kept in an incident log book.

Public safety

- 10. The Company's Health and Safety Policy will be regularly reviewed and all management and staff will be fully briefed and trained to standards required by relevant legislation.
- 11. Free drinking water will be available at all times.

The prevention of public nuisance

- 12.Additional patrols will take place by members of staff, internally and externally, to limit any noise pollution when entertainment is being offered within the premises.
- 13. Notices will be displayed asking customers to respect neighbours when leaving the premises.
- 14. Where currently in use text/radio pagers will continue to be used for the additional hours of trading and will be monitored by a responsible member of staff.

- 15.Soft drinks and non-alcoholic refreshment will be available for an extended period between the cessation of the supply of alcohol and the closure of the premises.
- 16. The outside drinking area will not be used by customers consuming food and/or drink after 23:00.
- 17. The gardens of the public house, except of the Designated Smoking Area identified on the site plan, to be closed at 23:00 with no food or alcohol being consumed outside after this time.
- 18. That use of external areas after 23:00 shall be restricted to the Designated Smoking Area as identified on the site plan.
- 19.Access to the Designated Smoking Area shall be monitored to ensure no food or drink is taken into the area after 23:00.
- 20. The Designated Smoking Area shall be regularly patrolled during opening hours to monitor noise levels from patrons.
- 21.Signage shall be erected to direct patrons to the Designated Smoking Area, to advise on restrictions on food and alcohol after 23:00 and to request patrons to have consideration for local residents. All signage to be agreed with the Licensing Officer at Tewkesbury Borough Council.

The protection of children from harm

- 22. The premises will adopt a 'Challenge 25' policy. This means that if a customer purchasing alcohol appears to be under the age of 25, they will be asked for proof of their age, to prove that they are 18 years or older. Notices must be displayed in prominent positions indicating that the Challenge 25 policy is in force. The only forms of identification that will be accepted at the premises are a passport, UK photocard driving licences, military ID & cards bearing the 'PASS' hologram.
- 23. The Premises Licence Holder shall operate and maintain an up-to-date 'Register of Refusals' of Sale of Alcohol / Incident Book indicating the date, time and reason(s) for refusal / incident that has taken place. The DPS shall check the book once a month ensuring that it is up to date. The DPS will sign and date the book each time it is checked. The book shall be made available for inspection upon the request of a duly authorised officer of the Licensing Authority or Police.
- 24. The Designated Premises Supervisor (DPS) shall ensure that all Staff concerned in the sale of alcohol are trained in their responsibilities under the Licensing Act 2003, particularly concerning drunk sales, underage sales and proxy sales. Training will include challenging every individual who appears to be under 25 years of age and to refuse service where individuals cannot produce acceptable means of identification, and using the refusal register. Such training (including any refresher training) will be logged and provided not less than every twelve months. The training log shall be made available for inspection by Police and "authorised persons" immediately upon request.
- 25. Children will be required to be supervised by the accompanying adult at all times.
- 26.Soft drinks and non-alcoholic drinks will be available.


The prevention of crime and disorder

- 27.Alcoholic drinks will not be discounted below the tariff in place for a minimum of one week after 18:00 hours on Friday and Saturday nights until the start of trading the following day.
- 28.Non-alcoholic/low alcohol drinks will be promoted especially to designated drivers of groups.
- 29. The Designated Premises Supervisor will be a member of a Pubwatch Scheme in Tewkesbury.

The prevention of public nuisance

- 30.On any evening when the premises are open after midnight, for a period of 30 minutes following the end of the supply of alcohol or until all customers have dispersed from the immediate vicinity, the Designated Premises Supervisor or a member of staff will be positioned immediately outside the premises to monitor the dispersal of customers.
- 31.On any evening when the premises are open for entertainment/music, other than low level background music, beyond 23:00 hours, all windows and doors shall remain closed, other than when persons are actually entering or leaving the premises, in order to reduce noise escape.
- 32. The designated premises supervisor will ensure the effective overall management of live or recorded entertainment, such as by monitoring noise levels outside the premises to ensure that noise from such activities is effectively inaudible inside neighbouring premises after 23:00 hours.
