Annex 1 – Mandatory conditions

Alcohol

No retail sale of alcohol may be made under the premises licence:

- (a) At a time when there is no designated premises supervisor in respect of the premises licence, or
- (b) At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every retail sale of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Exhibition of Films

Where a programme includes a film which has been classified by the British Board of Film Classification as 12 A, 15 or 18 category no person appearing to be under 12 (and not accompanied in that case), 15 or 18 as appropriate shall be admitted to any part of the programme.

Annex 2 – Conditions consistent with the Operating Schedule

General

The premises licence holder will ensure that all staff at the premises are trained in accordance with established JD Wetherspoon PLC training procedures.

The premises will be constructed in accordance with drawing number 06091-L01 as served with the application, or in the case of alteration to that drawing, any further drawing served on the responsible authorities and licensing authority prior to the opening of the premises.

Crime and Disorder

The premises licence holder shall adhere to the document “JDWS approach to responsible drinks retailing” as amended from time to time.

Non-Alcoholic beverages including soft drinks, drinking water, coffee and tea shall be available at all times sale by retail of alcohol is carried out at the premises.

The licence holder shall take reasonable steps to ensure the DPS or a nominated member of staff shall be a member of Pubwatch or a similar scheme where available who shall use his or her best endeavours to attend regular meetings of such a scheme.

CCTV shall be installed at the premises in compliance with any reasonable requirements of the police crime prevention officer and images will be retained for 31 days and made available to the police on request.

Toughened glass shall be used throughout the premises.

A full food menu shall be available to customers until the terminal hour for the sale of alcohol.

An area of the premises will be a set aside dining area at all times with priority given to customers wishing to eat.

The premises licence holder will risk assess the requirement for door supervisors in conjunction with Gloucestershire Police and shall employ door supervisors in such numbers and at such times as required by the risk assessment.

Liaison will take place between the premises licence holder and the Gloucestershire Constabulary on an ongoing basis as to operational measures designed to address the prevention of crime and disorder, such measures may include for example, but shall not be limited to promotions on soft drinks at certain times and promotions to encourage uptake of food after 2200.

Public Safety

The premise will be constructed and will operate in accordance with all health and safety and related legislation in order to ensure the safety of customers and staff.

Prevention of Public Nuisance

See conditions b) to b) 4 above

The premises licence holder will adhere to the dispersal policy as amended from time to time which accompanies the application to vary the premises licence submitted to the licensing authority on 2nd August 2007.

The Protection of Children form Harm

The premise licence holder will operate a "Challenge 21" policy.

Children under the age of 16 shall not be allowed on the premises beyond 21.00 or 23.00 if eating a meal. Families with children under the age of 16 wishing to dine after 21.00 shall only be permitted to dine in the drawing room as indicated on the plan see Annex 4

Children under the age of 16 must always be accompanied by an adult who will be required to maintain supervision of them.

Suitable food and non-alcoholic beverages shall be available at all times children are allowed on the premises.

Police Agreed Conditions

There shall be no NEW admission to the premises between 2330 New Years Eve and 0400 New Years Day.

There shall be no discounting of alcoholic drinks after 1800 on Friday and Saturday nights until the start of trading the following day. (For the purposes of this condition a discounted drink is one sold at a price below the tariff in place for that drink for a minimum period of one week before the relevant Friday or Saturday night.
