NOTICE OF DISCLOSURE OF PECUNIARY AND OTHER INTERESTS

DISCLOSABLE PECUNIARY INTERESTS

Any contract which is made between you or the persons referred to above (or a body in which you or they have a beneficial interest) and the Parish Council a) under which goods or services are to be provided or works are to be executed; and b) which has not been fully discharged.

- ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you, or the persons referred to above, has a beneficial interest exceeds one hundredth of the total issued share capital of that body.


- 1) omit information that ought to be given in the Notice;
