#### NOTICE OF DISCLOSURE OF PECUNIARY AND OTHER INTERESTS

This includes any payment or financial benefit from a Trade Union within the meaning of Trade Union and Labour Relations (Consolidation) Act 1992.

Any contract which is made between you or the persons referred to above (or a body in which you or they have a beneficial interest) and the Parish/Town Council a) under which goods or services are to be provided or works are to be executed; and b) which has not been fully discharged.
