NOTICE OF DISCLOSURE OF PECUNIARY AND OTHER INTERESTS

I, KENNETH A WRIGHT a Member of the Stanton Parish Council ("the Parish Council"), set out below under the appropriate headings the interests which I am required to declare under the Localism Act 2011 and the Parish Council's Code of Conduct and I have put 'none' where either I have no such interests under any heading or I am unaware of such an interest.

DISCLOSABLE PECUNIARY INTERESTS

Any contract which is made between you or the persons referred to above (or a body in which you or they have a beneficial interest) and the Parish Council a) under which goods or services are to be provided or works are to be executed; and b) which has not been fully discharged.

 - ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you, or the persons referred to above, has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

- 2) provide information that is materially false or misleading;
- 3) fail to provide written notification to the Monitoring Officer of any change in my interests contained in this Notice within 28 days of my becoming aware of such change of circumstances.

I understand that under Section 29 of the Localism Act 2011 there is a legal requirement for the Register of Members' Interests to be published on the internet.


