NOTICE OF DISCLOSURE OF PECUNIARY AND OTHER INTERESTS

I, RICHARD THORNHILL a Member of the Stanton Parish Council ("the Parish Council"), set out below under the appropriate headings the interests which I am required to declare under the Localism Act 2011 and the Parish Council's Code of Conduct and I have put 'none' where either I have no such interests under any heading or I am unaware of such an interest.

PART A

DISCLOSABLE PECUNIARY INTERESTS

Members are required to register not only their own interests but also those of their spouse or civil partner, or a person with whom the Member is living as if they were a married couple or civil partners, and the Member is aware that that other person has the interest.

1. EMPLOYMENT, OFFICE, TRADE, PROFESSION OR VOCATION

Any employment, office, trade, profession or vocation carried on by you, or those persons referred to above, for profit or gain.

This includes any payment or financial benefit from a Trade Union within the meaning of Trade Union and Labour Relations (Consolidation) Act 1992.

3. CONTRACTS

Any contract which is made between you or the persons referred to above (or a body in which you or they have a beneficial interest) and the Parish Council a) under which goods or services are to be provided or works are to be executed; and b) which has not been fully discharged.

 - ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you, or the persons referred to above, has a beneficial interest exceeds one hundredth of the total issued share capital of that class.
