NOTICE OF DISCLOSURE OF PECUNIARY AND OTHER INTERESTS

I, SIMON ANTHONY CLAYSON a Member of the TWYNING Parish Council ("the Parish Council"), set out below under the appropriate headings the interests which I am required to declare under the Localism Act 2011 and the Parish Council's Code of Conduct and I have put 'none' where either I have no such interests under any heading or I am unaware of such an interest.

PART A

DISCLOSABLE PECUNIARY INTERESTS

Members are required to register not only their own interests but also those of their husband or wife, civil partner or of any person with whom they are living as if husband or wife or as civil partners when such interests are known by them.

Any contract which is made between you or the persons referred to above (or a body in which you or they have a beneficial interest) and the Parish Council a) under which goods or services are to be provided or works are to be executed; and b) which has not been fully discharged.

- (b) either:-
 - i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or
 - ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you, or the persons referred to above, has a beneficial interest exceeds one hundredth of the total issued share capital of that class.


- 1) omit information that ought to be given in the Notice;
