I also acknowledge that it may be a breach of the Code of Conduct to:-

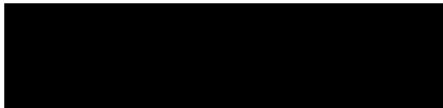
- 1) omit information that ought to be given in this Notice;
