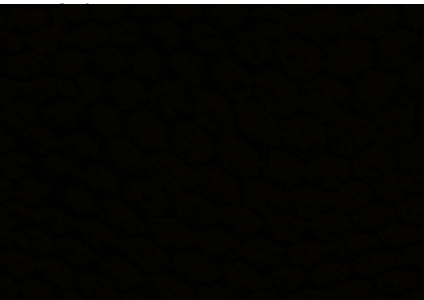

I understand that under the Localism Act 2011 there is a legal requirement for the Register to be published on the internet.

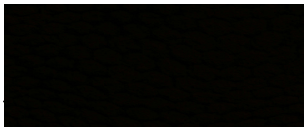
